





DISCIPLINE AND GENERAL RULES

General Conduct

- Students Shall Show Due Respect To Teachers, Staff, And Fellow Students.
- Students Should Act Responsibly And Must Not Harm Or Damage College Buildings, Books, Equipment, Furniture, Etc. Any Cost Of Damage Will Be Recovered From The Student.
- Students Are Expected To Use Polite And Respectful Language And Behave With Decorum When Interacting With Faculty And Staff.
- Any Political Or Immoral Activity Is Strictly Prohibited In Or Around The College Premises.

Attendance & Punctuality

- Every Student Is Required To Be Punctual In Classes.
- No Student Is Allowed To Leave The Classroom Without The Permission Of The Teacher Or Until The Class Is Over.
- A Student Arriving Late Will Be Marked Absent Unless A Valid Excuse Is Accepted By The Teacher.

Permission & Communication

- Without Prior Permission From The Principal, No Student Is Allowed To Paste, Exhibit, Prepare, Or Distribute Any Poster, Leaflet, Notice, Pamphlet, Or Handbill On College Premises.
- Students Are Forbidden To Contact Any Higher Authority Directly. Any Communication Intended For Higher Authorities Must Be Submitted Through The Principal.

College Premises Rules

- Smoking In The College Premises Is Strictly Prohibited.
- Strict Silence Is To Be Observed In The Library. Gossiping Is Prohibited.
- No Damage Should Be Done To Library Books Or Other Literature. Cost Of Any Damage Will Be Recovered From The Student.

Classroom Behavior

- Misbehavior In The Classroom Shall Be Immediately Reported To The Principal By The Teacher.
- The Principal Will Take Appropriate Action; Teachers Can Recommend A Penalty.

Academic and Examination Rules

- Admission Policy Is As Per The University Of Punjab.
- Students Must Appear In All Mid-term And Final-term Examinations As Per The Announced Schedule. Parents/guardians Will Be Informed Of Performance Accordingly.

College Authority

- The Decision Of The Principal Shall Be Final In All Cases.
- The Principal has discretionary powers to relax any rule if deemed necessary.
- The College Reserves The Right To Make, Amend, Or Introduce Any Rule As Considered Appropriate.

Fee Policy

- There Will Be A 15% Annual Increment In The Fee Package Or As Per College Administration Policy.
- Examination And Registration Fees Are Not Included In The Fee Package.
- Dues Once Paid Are Non-refundable And Non-transferable.
